<u>Public Comment-Open</u> at 7:10 p.m. Dennis Mitchell 5260 North Road had concerns again about his neighbor to the south of him, Kingdom Landscaping. The neighbor has been burning all week plus he is having other trucks drop off brush to burn. Mr. Mitchell has pictures of the other trucks. It was mentioned that a youth camp with loud music is going on next door. Rod stated the Planning Commission decided years

ago to allow the building. Rod also stated that he had talked to the man to keep the fires small and not allow other trucks to dump their brush. Supervisor Manoleas stated that the Township will continue to look into this. Public Comment closed at 7:21 p.m.

### Reports

**Report from Building Department-**Rod Cowan/One storage building/with living space above, one house addition, one porch w/roof, one window replace, one deck, one repair doorway/stairway, one metal roof and two certificate of occupancies.

**Report from the Ordinance Officer-**Rod Cowan/See attached report.

Report from the Fire Department-Gary May/Clerk Turner read report submitted. Nine medical emergencies, four personal injury accidents, two weather warnings one tree in roadway and one public assist. Two firefighters are currently attending MFR class at Tri Hospital. The Department is expecting them to be licensed by September. Both tornado sirens did activate during the testing last month. Hose and ladder testing and certification will be completed on 7-17-19.

**Report from the Planning Commission**- No official business talked about, no quorum present.

Report of Parks and Recreation Committee-Sherry Beiser Walter submitted report, Clerk Turner after the meeting/Next meeting will be August 12<sup>th</sup> at Bill Bearss Park. The plan is to have a short meeting and then have cleanup of the park. Still are trying to schedule the boy scouts to help with some projects. Don's Tree Service will be removing some dead trees between the Township Park and Jake's Park. The Committee is still working on getting a couple more bids for dugout roofs. Looking to replace with a metal roof.

Report from the Cemetery Advisory Committee— Franz Neruda reported the Committee discussed the replacement of the Kinney Cemetery sign, plus talked about the gravel for the driveways. DPW keeping up with the grass very well. Discussed the need to remove a diseased spruce tree and take the bushes down by the sign in Kinney Cemetery. A Special Meeting on August 7 is scheduled to discuss Cemetery Ordinance. It was reported by the Sexton that there is more damage and vandalism still going on in Ruby Cemetery. Chairperson Neruda mentioned about getting two cameras for this situation.

# Correspondence

Supervisor Manoleas and Clerk Turner presented various

correspondence.

Supervisor Manoleas read letter submitted by Bill Dedoe. This letter stated that a new procedure is needed in asking for time off. Supervisor Manoleas stated that this issue has been taken care of. He also reported that Hi-Tech's test came back at 100%. He also mentioned about MTA is offering a Planning Commission and Zoning class up in Frankenmuth. He suggested it would be a good class to attend, it is August 20<sup>th</sup>.

Clerk Turner read a letter that Connie Bates submitted. (Attached to these minutes.)

It was also discussed about hanging things in the new Hall. A suggestion about forming a Committee for this task. The Committee will consist of Clerk Tuner, Helen Hermes, and Clerk Turner will ask Stacey Smith. A thought about looking at other townships to possibly get ideas was discussed.

#### **OLD BUSINESS:**

#### ORDINANCE #73 WIND

Discussion about this Ordinance and the need to approve it because it is listed in the proposed Ordinance #74 Noise. It was given to the Board members last month for their consideration. Treasurer McGriff stated that the Planning Commission worked hard on this Ordinance and that it is a very good Ordinance.

#### **BUILDING ISSUE**

Resident Robert Hoffman, at 5470 Robinwood Drive built an addition to his existing pole barn without a permit. Mr. Hoffman went before the ZBA for a variance on the height of the pole barn in 2015. The variance was granted with a condition that the porch area to the pole barn could not be used for storage. Discussion. Mr. Hoffman admits that he was wrong and should have gotten a permit. He is almost finished with the addition on the porch area of the pole barn. Supervisor Manoleas asked Mr. Hoffman that he indeed did understand the procedures of acquiring a building permit. The answer was yes. More discussion. Mr. Hoffman stated that his neighbor is selling his house, and asked would it be okay to put the shingles and siding on the addition to make it look better. The Board answered "no". Supervisor Manoleas will address this issue with the Township attorney. The Township will legally abide by the Ordinance. Supervisor requested that this topic be on next month's agenda. It was suggested that a Special Meeting could be ordered when the Supervisor gets information from the attorney.

## FIRE GEAR BIDS

Trustee Dortman stated that some of the fire gear the Fire Department has is not in compliance.
