**STATE OF THE TOWNSHIP ADDRESS**

Supervisor Manoleas stated the purchase of Engine 1 for the Fire Department. Also the new sign out front of the Township Hall. The Township is doing Wadhams Road using the Local Road Funding Assistance Program from the County Road Commission. Abbottsford Road was done by the County, just recently. Culvert work in the Ponderosa sub-division is still being done. Also with a just recent rain, it brought out a drainage problem in the area of Krafft Road and North Road, along with Wadhams Road. He has already discussed this with the Road Commission. He also reported that the Township almost has a completed water reliability study. He wants to accomplish this water topic because this is his last run and he will give a major push to this topic.

Clerk Turner added a part time general secretary resigned. Hired a new gal Miranda to the office staff. She is working out very well. The Township signed a 2 year contract with the Assessor. Amended and restated Water Ordinance #49 and #51 so that is easier to read. Also the Planning Commission developed a Noise Ordinance #74. Township also got a new credit card. Township Board appointed members to various boards and committees. Also the Township has started efforts for a Civil War Vets Memorial.
