IF THE ABOVE SPACE(S) IS CERTIFIED AS ABANDONED A PERSON WHO POSSESSED THE RIGHT MAY BE ENTITLED TO REMEDIES AVAILABLE UNDER SECTION 17 OF THE MICHIGAN CEMETERY REGULATIONS ACT, 1968 PA 251, MCL 456.537, INCLUDING:

- (A) REINSTATEMENT OF THE RIGHT IF THE RIGHT HAS NOT BEEN RESOLD OR OTHERWISE TRANSFERRED TO ANOTHER PERSON.
- (B) IF THE RIGHT TO THE SPACE HAS BEEN RESOLD OR OTHERWISE TRANSFERRED TO ANOTHER PERSON, AT THE OPTION OF THE PERSON WHOSE RIGHT WAS CERTIFIED AS ABANDONED, EITHER OF THE FOLLOWING:
  - (I) A DIFFERENT RIGHT TO A SPACE OF COMPARABLE VALUE WITHIN THE CEMETERY.
  - (II) COMPENSATION IN THE AMOUNT THAT THE PERSON WHOSE RIGHT WAS CERTIFIED AS ABANDONED PAID FOR THE RIGHT OR IN AN AMOUNT EQUAL TO 65% OF THE PRICE FOR WHICH THE RIGHT WAS RESOLD OR OTHERWISE TRANSFERRED BY THE CEMETERY OWNER OR OPERATOR, WHICHEVER AMOUNT IS GREATER.
