1. Approve the 2024-2025 Fiscal Year Budget

Supervisor Manoleas reported that there was public hearing held on the budget.

Motion by Supervisor Manoleas, supported by Trustee Voight to approve the 2024-2025 Fiscal Year Budget. Vote: 7-0. **Motion Carried.**

2. Deputy Treasurer Wage Increase

Treasurer Compton presented her deputies hours and pay. Asking the board to increase her wages.

Motion by Treasurer Compton, supported by Clerk Smith to approve the Deputy Treasurer wage increase to \$15,000.00 a year. Vote: 7-0. **Motion Carried.**

3. Ordinance Officer Wage Increase

Trustee DeShon would like to recommend that the new hire start out at \$10, 000.00 a year. Discussion held.

Motion by Trustee Neruda, supported by Treasurer Compton to increase the Ordinance Officer wage for the new hire to \$10,000.00 per year. Vote: 7-0. **Motion Carried.**

4. Building Inspector Wage Increase

The building Inspector presented the schooling he has to do to keep up his license, the hours he has to put in and is currently playing catch up on inspections from previous building permits. Discussion held.

Motion by Trustee Neurda, supported by Trustee DeShon to increase the Building Inspectors wages to \$30,000.00 per year. Vote: 5-2 **Motion Carried.**

5. Tanker 42 Repair

Chief Dortman presented a quote for additional repairs on Tanker 42. Discussion held.

Motion by Trustee Neruda, supported by Trustee DeShon to approve the quote in the amount of \$3,969.07 for Taker 42 repairs. Vote: 7-0 **Motion Carried.**

6. DPW Class III New Hire

Discussion held on applicants and interviews.

Motion by Supervisor Manoleas, supported by Trustee DeShon to hire Seth Vincent for the DPW Class III position contingent upon passing the S-4 water license within 3 years. Vote: 7-0. **Motion Carried.**
