**WORK ORDERS FROM THE ROAD COMMISSION**

Received an envelope from the Road Commission with various work orders in it. It was determined prior to the meeting on the Road trip to consider the limestone and calcium chloride work orders first, in order to get on the County's list. The rest of the work orders will be considered at the next Board meeting.

- Motion by Supervisor Manoleas support from Trustee Voight to approve the work order for the 2 applications of calcium chloride in the amount of \$41,000.00. Yeas: 6 Nays: 0 Motion carried.
- Motion by Supervisor Manoleas support from Trustee Neruda to approve the work order for 75 loads of limestone in the amount of \$71,994.00. Yeas: 6 Nays: 0 Motion carried.
- Motion by Supervisor Manoleas support from Trustee Voight to approve the 80/20 limestone work order in the amount of \$4,992.00 the Township's cost. Yeas: 6 Nays: 0 Motion carried.

It was stated that Todd the County foreman mentioned that the Township has taken such good care of the gravel roads that this expenditure should be less next year.

**ASSESSOR**

Discussion on the hiring of Elisha A. Messina. The ad for hire was in the Assessor's magazine and was advertised on the county level. Supervisor Manoleas stated that he received one inquiry and one application for the job. The Assessor Committee interviewed her on the previous Friday. The Committee recommended her for the position. She is a highly qualified person and has great qualifications, MAACO class three license and is also the Treasurer in Wales Township.
